# **PRIVACY POLICY**

50.8 are dedicated to keeping your informations private. Any information that we collect in relation to you is kept strictly secured.

FPE Bvba – 50.8 ("50.8 Studio", "50.8 Shop", "50.8 Rentals", "we", "us, and "our") provides you with access to our sites: www.fiftypointeight.be, www.fiftypointeight.studio, www.fiftypointeight.shop, www.fiftypointeight.rentals. This Privacy Policy explains how certain information about you may be processed. By using this site and placing orders, you expressly consent to the use of your data in accordance with this Privacy Policy.

# 1. WHAT WE COLLECT AND WHAT WE DO WITH YOUR INFORMATIONS ?

When you place an order from our store, we collect the personal information that you provide to us such as your personal and/or company name, billing address, VAT and/or phone number, email address, credit card/ payment details and optional account information like username and password.

These informations are necessary for us for invoicing to you our product and services. Send you information about your account and order. Respond to your requests including refunds and complaints. Process payments and prevent fraud. Set up your account for our store. Comply with any legal obligations we have, such as calculating taxes. Improve our store offerings. Populate the checkout for future orders.

We store information about you for as long as we need the information for the purposes for which we collect and use it. If you placed an order/booking we are legally required to keep it for 6 years for tax and accounting purposes. This includes your name, email address and billing and shipping addresses.

When you browse our store, we also automatically receive your computer's internet protocol (IP) address in order to provide us with information that helps us learn about your browser and operating system.

We also may send you emails about our promotions, new products and other updates.

If you do not wish to remain a subscriber to our mailing list or otherwise receive updates on our products and services, you are able to remove your details from the subscriptions list on the bottom of each promotional emails.

# 2. CONSENT

How do you get my consent ?

When you provide us with personal information to complete a transaction, verify your credit card, place an order, arrange for a delivery or return a purchase, we imply that you consent to our collecting it and using it for that specific reason and personal marketing only.

#### How do I withdraw my consent?

At anytime you can request to receive an exported file of the personal data we hold about you, including any data you have provided to us. You can also request that we erase any personal data we hold about you. This does not include any data we are obliged to keep for administrative, legal, or security purposes.

## 3. DISCLOSURE

Our websites are propulsed on a WordPress and WooCommerce, all data storage, databases are securely hosted on 1&1 Internet AG (Brauerstr. 48, 76135 Karlsruhe – Germany).

Stripe Technology Europe (25/28 North Wall Quay, Dublin 1, D01H104 — Ireland), will use the information we collect as part of the payment processing practice. When you use Stripe payment on 50.8 website to store your payment credentials, Stripe Technology Europe will use the Personal Information disclosed to 50.8 (SECTION 1) to complete purchases that you choose to make.

Your data is stored through Stripe Technology Europe data storage, databases and the general Stripe Technology Europe application. They store your data on a secure server behind a firewall.

Where you submit a payment via the Website, you will be providing your credit card details to our payment gateway service provider, Stripe Technology Europe. Your credit card details are not stored by the Service and cannot be accessed by 50.8 staff. You should refer to <u>Stripe's Privacy Policy</u> for details regarding how Stripe Technology Europe uses and discloses your credit card details and any other personal information it collects.
